Tuition Agreement: I understand the studio's policy on timely payments for the plan I have chosen. I further understand that my credit card on file will be charged for the monthly installments and my outstanding account balance. Charges such as dancewear, tee shirts, special event fees and snacks purchased at the studio will be paid as they are incurred and not added to my account statement. I understand that there is an irrevocable late fee of \$30 for monthly tuition payments received after the 5th of the month. The last payment for all accounts is due by May 1st and will include June's payment if paying monthly.

I understand that there is no pro-rated discount or refund for classes missed, for any reason, for the period I have paid for. Classes missed due to inclement weather/studio closings will be made up during Spring Break or another time at the discretion of the Instructor for the missed class(s). I understand that tuition hours are based on a 10 month dance year divided into monthly payments. **If I wish to drop a class(s)** that results in lower tuition hours for the year, I will forfeit any pre-payment discounts retroactive to September 2019. **If I must drop a class(es),** I understand that I must come to the studio and fill out a drop form prior to the next payment due date (before the 1st of the month or bi-monthly payment due date). If you cannot come into the studio, we require you to mail in a signed dropped form BEFORE the next installment due date. **First month and last month (June) tuition is due upon registration. June tuition is NON-REFUNDABLE.** Costume Fee (\$75 per class) is due 11/15/2020. Once purchased, Costume Fee is also NON-REFUNDABLE.
